

ATLANTIC MOTOCROSS RACING ASSOCIATION

Code of Conduct

Effective as of: February 10, 2025

The following defines behavior at all events of Atlantic Motocross Racing Association (AMRA):

1. *Drinking of alcoholic beverages or Consumption of Cannabis Products.* No member competing in the event shall engage in the drinking of alcoholic beverages or Consume Cannabis Products with THC during an Event, including from the time practice starts until the Participant's last race is concluded.
2. *Drug use.* No Participant shall engage in illegal drug use while at a Facility.
3. Participants shall not knowingly compete while intoxicated either by alcohol or drugs.
4. At Facilities where it is permissible to ride in the pits to and from the starting line, a speed of first gear only shall be observed.
5. Participants and their pit crews shall not direct offensive or intimidating language, verbal or physical abuse or destruction of property towards fellow competitors, officials, pit crews or spectators. This applies to all forms of communication including verbal, digital or written. Consequences for this violation shall be swift and immediate and shall result in the expulsion of the offending rider and their entire pit crew from that day's Event. This offence will then be dealt with through the By-laws of AMRA.
6. Participants and their pit crews shall not physically assault other Participants. Any off-track fighting that occurs within a Facility will be immediately referred to the proper authorities. Any form of off-track fighting shall result in a 3 round suspension and referred to the Board. Notwithstanding anything contained in this Code of Conduct, AMRA reserves the right to discipline any Participant for off-track conduct regardless of when or where it occurs. This is a 24 hour a day, 7 day a week rule.
7. No one shall discharge oil or chemicals onto the ground of the race facility and shall dispose of all trash and waste into approved containers or pack them out of the facility.
8. Any pets that members bring to the event shall be leashed and not allowed to roam freely around the facilities.

9. Participants shall be responsible for the actions of those who accompany them to the race. This includes pets, family members and pit crew. Participants shall bear the penalty for any violation of the Code of Conduct committed by those associated with the Participant.
10. If a Participant feels there has been a violation of the Code of Conduct rules, they may report this to the Facility Member, the Rider Rep, or the person acting on the Board's behalf at the Event. The Board may or may not request the alleged misconduct complaint to be in writing. Code of Conduct violations are not protests and do not require a one-hundred-dollar (\$100.00) fee.
11. Any violation of the preceding Code of Conduct rules will subject the violator to any level of discipline from a simple warning to expulsion from the Facility or all Facilities. Race day penalties are determined by the Facility Member or that person acting on the Board's behalf at the event. Long term penalties are assessed at the discretion of the Board.
12. Terms used herein but not defined have the definition set out in the By-laws of AMRA.
13. By joining AMRA, competitors acknowledge that discipline for violations is determined by the Board and agree to respect and abide by those decisions in all such matters.
